VENDOR AGREEMENT

Roadshow Market Vendor Agreement Organized by Laray Event Management Gladewater Round-Up Rodeo Grounds

April 25-26, 2025

Friday: 9 AM-7 PM | Saturday: 9 AM-7 PM

Setup: 90 minutes before event start | Tear-down: 90 minutes after event ends

NO BACKUP DATE: Fee will be applied to an alternative event only. NO REFUNDS.

Balance Due by 04/20/2025

Terms and Conditions:

Event Logistics: Vendors must be fully set up before event start. Spaces are 12x10 feet; additional spaces available. Displays must be professional; no handwritten signs. Vendors must provide trash bins. Tents must be flame-retardant and weighted.

Food Trucks: Menus must be pre-approved. All permits and liabilities are the vendor's responsibility. No refunds for non-compliance. Trucks cannot sell beverages of any kind.

Vendor Responsibilities: Vendors must comply with all sales tax laws and provide applicable insurance. Multiple brands require separate spaces. Vendors cannot sell hot food or beverages of any kind.

Non-Profits: No on-site health screenings. Raffle items must be valued at \$499+ and pre-approved.

Utilities & Lighting: Vendors must bring generators and provide adequate lighting if staying open after dark.

Payments: Full payment due by DUE DATE. Late fees apply. No refunds for any reasons. No-shows incur a penalty of up to 10x the space fee.

Prohibited Items: No alcohol, tobacco, CBD, weapons, or adult-themed items. Packaged foods are allowed under Cottage Laws.

Media Use: Organizer may use vendor images for promotions throughout the company as well as with other vendors, partners or affiliates.

Indemnification: Vendors agree to hold Laray Event Management harmless from any and all claims.
